TRUST DEED

This DEED OF TRUST made this the _____ day of _____ 198____ between SHRI CHUDAMAN ANANDA PATIL, Resident of Mohadi, Pra. Laling, Dhule, hereinafter called the "SETTLOR" (which expression shall unless excluded by or repugnant to context be deemed to include his executors, administrators and representatives) of the ONE PART and (1) Dr. SHRI BHIDAS CHUDAMAN PATIL, Lane No. 4, Dhule, Chairman, (2) Dr. SHRI VISHWAS CHUDAMAN PATIL, Lane No. 4, Dhule, Secretary, (3) SHRI BALASAHEB alias SHRI EKNATH VITTHALRAO VIKHE PATIL, Pravara Nagar, Shreerampur, Ahmednagar, (4) SHRI BALMUKUND ^{ज.व. पाटील} PASARI, Parola Road, Dhule, (5) SMT. PUSHPAVATI VYANKATRAO HIRE, Malegaon, District Nasik, (6) SHRI BHAURAO MAHARU PATIL, Hirapur, Chalisgaon, District

These above hereinafter jointly referred to as " TRUSTEES " or " BOARD OF TRUSTEES " (which expression unless excluded by or repugnant to the context be deemed by or repugnant to the context be deemed to include the Trustee or Trustees for the time being of these present and their successors in office) of the OTHER PART.

W H E R E A S :

- (a) The SETTLOR is desirous of establishing a Fund for public charitable objects; and
- (b) The TRUSTEES have at the request of the Settlor agreed to act as the First Trustees of these presents as testified by their being parties to and executing these presents,

Now this Indenture witnesseth as follows :-

(1) In order to effectuate his said desire the SETTLOR has handed over to the Trustees a sum of Rs. 10,000/- (Rupees Ten Thousand only) by cheque No. dated on Bank Dhule to hold and stand possessed for the same (hereinafter for brevity's sake referred to as " TRUST FUND " which expression shall include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of Law or otherwise

howsoever in relation to these presents) upon the Trust and with and subject to the powers, provisions, agreements and declaration, hereinafter declared and contained of and concerning the same.

(2) The name of the Trust shall be " JAWAHAR MEDICAL FOUNDATION ", and its activities shall extend to whole of the India.

(3) The objects for which the Trust Fund is established are medical education, medical research, medical relief to the public and any other object incidental and related to medical education, medical research and medical relief to the public in general in India and for this :

(a) To establish, maintain, run and or grant aid in cash and or in kind to medical schools, medical colleges

and institution conducting medical diploma or degree courses.


(b) To establish, maintain run and/or grant, aid in cash and/or in kind to Hospitals, Nursing Institutions, Sanitoria, charitable and/or travelling dispensaries, after-care clinics, maternity homes, child welfare centres, orphanages, widows homes and/or such other similar charitable institutions for the benefit and use of the public in general.

(c) To establish, support, acquire, run and/or grant aid and other financial assistance to Medical Research Laboratories and other related Scientific research institutions.

(d) To establish, maintain, acquire, run and/or grant aid and other financial assistance to Hostels and Boarding Houses, Chaultry, Dharamshala and the institutions or like nature for the students staff and the patients coming from mofussil and surrounding area.

(e) To establish, maintain, run and or grant aid to the Homes and institutions for providing help to the physically handicapped, destitute poor and needy without making any distinction of caste, colour and creed.

(f) To establish, run, maintain and/or grant aid to the institutions for providing fuel and other materials to the families of the deceased persons for the disposal of dead bodies and also to construct, repair and manage the Marghats, cemeteries, burial grounds etc. without caste, creed or religion.

(g) To establish, maintain and/or run studentships, scholarships and render other kind of aid to individuals and students, including provisions of medicines, books, stipends, medals and other incentives for promoting medical research and advancement of medical knowledge and education without distinction of caste, creed and religion.

(h) To conduct scientific research in basic sciences in relation to medicinal, clinical and applied medicines, nutrition and any other problem related to community health and medical aid.

5 The Trustees shall cause true and accurate accounts to be kept of all monies received and spent and of all matters in respect thereof in the course of management of trust properties or in relation to the carrying out of the objects and purposes of the trust as well as of all assets credits and effects of the Trust properties.

6 For the furtherance of the objects of the Trust and in accordance with the provisions of the Income Tax Act for the investment or use of the Trust Funds for the time being in force, the trustees will have the following powers :

(a) To accept any donation, contribution, grant or subscription in cash or in kind from any person, Government, semi Government institution, body of persons, trust etc. with or without conditions.

(b) To apply the whole or part of the income of the

Trust Fund or accumulation thereof or whole or part of the Trust Fund to any one or more of the objects of the Trust as the Trustees may in their discretion determine from time to time.

(c) To convert and deal with the trust property and/or carry the investment for the time being.

(d) To invest and keep invested the Trust Fund as per section 11(5) of the Income Tax Act 1961 as amended from time to time.

(e) To borrow or raise or secure payments of monies either with or without securities.

(f) To sell, dispose off, alienate or otherwise deal with any property comprising the Trust Fund.

(g) To open account in the name of the Trust, Trustees and/or institutions run, conducted by the Trust with the Cooperative or Scheduled Bank or Banks, to operate such accounts and to give instruction to the Bank and to provide for opening and operation of such account by one or more of the trustees or by an agent appointed by the Trustees.

(h) To adjust, settle, compromise, compound refer to arbitration all actions, suits, claims, demands and proceedings regarding the Trust.

(i) To appoint constituted attorneys or agents and to delegate them all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in

his or their place.

(j) To appoint or make provisions for the appointment of any person (including all or any of the trustees and committees or administrators or Managing Trustees or otherwise) for the purpose of administration of the trust in such manner and subject to such rules, regulations as the Trustees may prescribe and also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of the deed in such manner subject to such rules and regulations as the Trustees may from time to time think fit.

(k) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

(l) To start, abolish, discontinue and restart any public charitable institution for the achievement of the objects of the Trust and to impose any conditions to any subscription or donation made by them.

(m) To set apart and/or allocate the whole or part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.

(n) To join, cooperate or amalgamate this Trust with other or others having similar objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in con-

7 It shall be lawful for the Trustees to give aid by way of donations out of the income of the corpus of the Trust Fund or otherwise, to different public charitable institutions, trusts, societies or organisations in India, which may have been established or which may have been established or which may hereafter be established for like purposes mentioned in these presents or to enable any of them to start, maintain or carry out the charitable objects which are mentioned in these presents.

8 The Trustees shall be chargeable only for such moneys and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglects, default act or omission or commission of other trustees, not of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.

9 The trustees shall not be entitled to receive any remuneration (except the honorarium for rendering service as medical or technical expert) but the trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

10 The number of the trustees shall not be less than two and more than eleven. If a number of the trustees shall fall below two the trustees shall not, except for the purpose of filling any vacancy act so long as the number is below the said minimum.

11 The trustees for the time being shall be at

liberty to appoint additional Trustees within the number mentioned above for such period or on such terms as to retirement and reappointment as the trustees for the time being consider proper. If any trustee dies, retires or becomes unfit or incapable to act, the continuing or surviving Trustee or Trustees shall be competent to appoint a trustee in place of the trustee's dying, retiring or becoming unfit or incapable to act. The decision for appointment of the new trustee shall be taken by majority of the continuing or surviving Trustee or trustees. A person shall cease to be a Trustee either (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year which ever is longer, or (ii) if he is requested to resign by majority.

12 Every Trustee shall be at liberty to resign on giving one month's notice of his intention to do so.

13 The Trustees may from time to time frame rules for conduct and regulation of the meetings of Trustees in the absence of such regulations :-

(a) Two trustees shall form a quorum for the meeting of the Trustees

(b) All matters shall be decided by the trustees mutually by majority of the trustees present of the meeting,

(c) Resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hands of majority of existing trustees

shall be as valid and effectual as a resolution duly passed at the meeting of the trustees.

(d) For calling the meeting of the Trustees as per advice of the Chairman, the Secretary shall give notice to the Trustees atleast seven clear days prior to the date of the meeting.


(e) The Chairman as mentioned in these presents shall preside over the meeting of the Trustees and the Secretary as specified in these presents shall act as the Secretary of the meeting of the trustees. If the Chairman is not present at the meeting of the Trustees, the present trustees shall by majority elect any one from amongst them to act as the Chairman of the meeting.

(f) All the resolutions of the meeting of the trustees shall be passed by majority of the trustees present at the meeting and in the event of equal voting the Chairman shall have one casting vote.

(g) The Secretary shall record clearly and correctly all the proceedings of the meetings of the Trustees.

14 Out of the seven trustees appointed by the Settlor (a) Dr. Bhaiddas Chudaman shall act as the Chairman and (b) Dr. Vishwas Chudaman Patil shall act as the Secretary of the Board of Trustees. In the event of their retirement, resignation or death, the remaining trustees shall appoint the Chairman and Secretary from amongst the Trustees then in office by majority.

15 The Chairman shall manage the affairs of the

trust with the help of salaried employees as per policies and directives laid down by the Board of Trustees.

16 The Secretary shall through the employees of the Trust look after the accounts, arrange for the meetings of the Board of Trustees, record the proceeding of the meetings in the minute book, deal with the correspondence of the trust as per direction, guidance and instructions of the Chairman and shall assist the Chairman in the management of the trust as per the advice of the Chairman.

17 The Trustees shall have the power and their uncontrolled discretion, instead of acting personally, to employ and pay an agent (including any Bank) to transact any business or to do any act whatsoever in relation to the trust of these presents, including the receipts and payments of moneys without being liable for loss and shall be entitled to be allowed and paid all charges and expenses incurred thereby.

18 The Trustees may delegate in writing all or any of his powers, under these presents to his nominee who will be entitled so long as such nomination remains in force, to exercise such powers in the same manner as the trustees himself could do personally.

19 The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of such capital or income any expenses or outgoings ought to be paid or borne and every such determination shall be binding and conclusive provided

that nothing contained shall be deemed to authorise the Trustees to spend income or corpus of the Trust for any purpose not authorised by these presents.

20 It shall be lawful for the Trustees to settle all accounts, to compromise, compound, abandon or refer to arbitration any action or proceedings or dispute, claim, demand or things proper for such purpose without being responsible for any loss occasioned thereby.

21 It shall be lawful for the Trustees to borrow money either on the security of any property comprised in the Trust Fund or authorise otherwise for all or any of the purposes of these presents and it shall be lawful for the trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

22 It shall be lawful for the Trustees :

(a) To apply to the Government, public bodies, urban local, municipal, district and other bodies, Corporation, Companies or persons for and to accept grant of money and of aid, donations, gifts, subscriptions and other assistance with a view to promoting the objects, of the Trust and to discuss and negotiate with them schemes and other work and matters within the objects of the Trust and to conform to any proper conditions upon which such grant and other payments may be made.

(b) To take over or amalgamate with any other public charitable Trust, Society or institution with similar objects.

(c) To establish, promote, manage, organise or maintain any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry out affiliation or amalgamation of such other trust with this trust.

(d) To take over, acquire, manage, control or aid any existing institution having objects, similar to the objects of this trust on such terms and conditions as may be thought expedient.

(e) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or of the Trusts or institutions with which this trust is authorised to amalgamate.


23 The accounting year of the Trust shall be ending on 31st March every year.

24 These Trust Funds shall be and remain irrevocable for all times.

25 The office of the Trust shall be situated at unless changed by the Trustees by two third majority.

26 It is expressly declared that no part of the trust property or its income or Trust Fund shall be applied for any purpose outside India or for any purpose which is not a public charitable purpose in law and all provisions hereof shall be construed accordingly.
